I feel as though I have learned not only about the legislative and legal processes in the Commonwealth of Massachusetts, but I feel as though I have learned to be more confident in my work and my ability to produce a convincing, well researched argument.

### **Impact on Future**

Due to the variety of background of many of my coworkers, I was exposed to many different career choices and was able to realize that I have many options in the future due to my time spent at this co-op. Not only was I able to work directly with lawyers who took me through their daily workload and its impact on our clients, but I was able to work with former campaigners for elected officials as high up as the House of Representatives, and former consultants who focused more on the business aspect of politics. Many of my coworkers have switched careers as well, showing that just because you start in one career doesn't mean your skills are not valuable in another. I was also able to spend much of my time networking with not only my coworkers but many clients as well, making it so that post graduation I have a safety net to fall back on with my many connections made.
